On October 28, 2005 an application was filed by Alltel Communications of Nebraska, Inc., Little Rock, Arkansas seeking a designation as an eligible telecommunications carrier under 47 U.S.C. Section 214(e)(2) of the Communications Act of 1934. Protests and interventions were timely filed by the Rural Telephone Coalition of Nebraska (RTCN)<sup>1</sup> and the Rural Independent Companies (RIC)<sup>2</sup> on November 28, 2005. A petition of informal intervention was filed by N. E. Colorado Cellular, Inc., d/b/a Viaero Wireless on November 18, 2005.
