O P I N I O N A N D F I N D I N G S

On March 7, 2006, the Nebraska Public Service Commission (Commission) granted the application of Alltel Communications of Nebraska, Inc., (Alltel), Lincoln, designating it as an eligible telecommunications carrier (ETC) pursuant to Section 214(e) (2) of the Communications Act of 1934 as amended. In the March 7, 2006, designation order, the Commission ordered Alltel to file its annual report required by Section 009.04 of the Commission's ETC reporting rules (Neb. Admin Code, Title 291, Chpt. 5, § 009.04) as provided above, on or before April 30th.

Subsequent to that order, the Commission in Docket NUSF-25/NUSF-66 required all ETCs to file investment and expense information with the Nebraska Telecommunications Infrastructure and Public Safety (NTIPS) Department so that the Department can review and certify their use of high-cost support. The deadline for the filing of this data to the NTIPS Department is June 1 of each year. The Commission's Order in NUSF-25/NUSF-66 superseded the five-year plan filing requirement in Section 009.04 of the Commission's ETC reporting rules.

On April 2, 2008, Alltel requested to change its April 30th deadline so that it can file all of its annual ETC filings with the Commission on June 1st. Section 009.04 of the Commission's ETC reporting rules allow a carrier, with permission of the Commission, to elect an April 30th or October 1st reporting deadline. Accordingly, we grant Alltel's request to change its annual ETC filing deadline so that it may file all of its annual ETC filings with the Commission on June 1st of each year.



