O P I N I O N A N D F I N D I N G S

By Motion to Reschedule Hearing filed on March 5, 2007, Qwest Corporation seeks a Commission order moving the hearing currently set in the above-captioned matters from April 10-11, 2007 to May 1, 2007. At the prehearing conference held on January 22, 2007 all interested parties agreed to the hearing date of April 10-11, 2007. However, subsequent to the prehearing conference, Qwest counsel discovered that two key witnesses for Qwest would be unavailable on those dates. Qwest therefore seeks an order moving the hearing date.

Qwest states in its Motion that it contacted the parties and all agreed that a hearing date of May 1, 2007 would be acceptable. Counsel for NT&T is set to be out of town on May 2, 2007, so the Commission would need to conclude the hearing in one day to avoid a conflict with NT&T.

Upon review of Qwest's Motion, the Commission is of the opinion and finds that the Motion should be granted and the hearing date moved from April 10-11, 2007 to May 1, 2007 at 1:00 p.m., in the Commission Hearing Room, 300 The Atrium Building, 1200 N Street, Lincoln, Nebraska. The Commission also finds it appropriate to move the testimony/comment deadline from March 30, 2007 to April 17, 2007. All exhibits corresponding to the testimony must be filed and served on interested parties by the April 17, 2007 deadline.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Qwest's Motion to Reschedule Hearing in the above-captioned matters be and it is hereby granted. The hearing date shall be moved from April 10-11, 2007 to May 1, 2007 as provided herein.

IT IS FURTHER ORDERED that the testimony/comment deadline be moved from March 30, 2007 to April 17, 2007 as provided herein.
