OPINION AND FINDINGS

By Petition filed on March 7, 2006, the Communications Department Public (Department) of the Nebraska Commission (Commission) opened this docket to collect and review the 2005 Annual Reports required pursuant to Neb. Rev. Stat. §86-159 (2004 Cum. Supp.). All interexchange carriers (IXCs) and competitive local exchange carriers (CLECs) who had not timely filed annual reports with the Commission were named as Several defendants had complied with the filing requirement, stipulated with the Commission, paid appropriate fines and were previously dismissed from the docket. September 12, 2006, the Commission entered an order assessing fines and revoking the certificates of authority for several carriers who remained in the docket.

However, the September 12, 2006 order gave Globalcom, Inc. until September 15, 2006 to comply with the filing requirements and reach a settlement with Commission staff. The order further stated that should staff and Globalcom, Inc. fail to reach an agreement or should Globalcom, Inc. fail to file the required information by September 15, 2006, an order assessing a fine and revoking their authority will be entered. Although, Globalcom, Inc. submitted financial information in compliance with the statute, it failed to reach a settlement with Commission staff regarding an appropriate fine.

Pursuant to the September 12, 2006 order, fines should be levied against Globalcom, Inc. consistent with the Commission approved fining schedule. Furthermore, Globalcom, Inc.'s certificate of public convenience and necessity issued to the defendant shall be and is hereby revoked.

Finally, as Globalcom, Inc. was the final defendant in this docket, the docket should be closed.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that fines be levied consistent with the Commission approved fining policy calculated as of the date of the hearing against Globalcom, Inc.

IT IS FURTHER ORDERED that the Certificate of Public Convenience and Necessity issued to Globalcom, Inc. shall be and is hereby revoked.

IT IS FURTHER ORDERED that Globalcom, Inc. shall cease and desist providing service in the State of Nebraska within 60 days from the date of this order. Furthermore, said carrier shall give at least 30 days notice of discontinuance of service to its customers and reimburse said customers any charges associated with obtaining service from a different carrier.

IT IS FINALLY ORDERED that this docket be and is hereby closed.
