## BY THE COMMISSION:

By application filed March 13, 2007, SBC Long Distance, LLC, d/b/a SBC Long Distance, d/b/a AT&T Long Distance, (SBCLD) California, is seeking authority to cancel certificate of authority to provide local exchange telecommunications services in the state of Nebraska, previously approved in Docket No. C-3145. Notice of the application was published in The Daily Record, Omaha, Nebraska, on March 15, No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

## OPINION AND FINDINGS

On April 27, 2004, SBCLD was granted authority to operate as a local exchange telecommunications carrier within the state of Nebraska pursuant to Application No. C-3145.

By application received on March 13, 2007, SBCLD requested the cancellation of its authority to operate as a local exchange carrier of telecommunications services in the State of Nebraska and the withdrawal of its Local Exchange Tariff, Nebraska PSC Tariff No. 9. SBCLD no longer has local exchange customers in Nebraska. SBCLD request cancellation of its local exchange carrier authority only. SBCLD's interexchange authority and interexchange tariffs will remain in place.

Upon consideration of the request and being fully advised, the Commission finds the request to be reasonable and finds that SBCLD's authority to operate as a local exchange carrier of telecommunications services in the state of Nebraska should be cancelled.

## ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-3780 be, and it is hereby, granted and the Certificate of Public Convenience and Necessity

to provide local exchange telecommunications services previously granted to SBC Long Distance, LLC, d/b/a SBC Long Distance, d/b/a AT&T Long Distance, is cancelled.

IT IS FURTHER ORDERED that the SBC Long Distance, LLC, d/b/a SBC Long Distance, d/b/a AT&T Long Distance's Local Exchange Tariff, Nebraska PSC Tariff No. 9 be, and is hereby, withdrawn.
