O P I N I O N A N D F I N D I N G S

On March 30, 2007, the Nebraska Public Service Commission (Commission) received an application from Total Call International, Inc., ("Total Call" or "Applicant") Los Angeles, California, seeking authority to operate as a resale carrier of interexchange telecommunication services within the State of Nebraska. Notice of the application was published in The Daily Record, Omaha, Nebraska, on April 5, 2007.

During routine processing of the application for financial fitness, Commission Accountant, Steve Stovall, discovered certain deficiencies with Total Call's application. As per Commission policy, on June 8, 2007, Mr. Stovall wrote a letter to Lance J.M. Steinhart, Esquire, the attorney for Total Call's application, requesting further financial information and included contact information for the Commission. On June 28, 2007, the Commission was contacted by Ms. Charlotte Lacey, a legal assistant of Mr. Steinhart, requesting three weeks time to respond to the request for further information from Mr. Stovall.

On August 6, 2007, Mr. Stovall informed Commission Attorney, Nichole Underhill, of the status of Total Call's application before the Commission. Ms. Underhill made telephone contact with Ms. Lacey requesting the required information concerning the application on two separate occasions on August 8, 2007.

As of the date of this order, the Commission has received no further response or communication of any kind from the Applicant or its attorney. Therefore, we find that a deadline for action to be taken by the Applicant in this docket should be set. If the Commission does not receive the requested financial documents or response from Total Call concerning this docket by **September 21, 2007**, the Commission will dismiss the application for failure to take timely action by the Applicant.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that a deadline for communication or response indicating further action and the filing of the requested financial documents in Docket C-3786 from Total Call International, Inc., be and is hereby set for September 21, 2007.

IT IS FURTHER ORDERED that if the Applicant fails to take action by September 21, 2007 in Docket C-3786, the Commission will exercise its authority to enter an order dismissing the application.
