## BY THE COMMISSION:

### OPINION AND FINDINGS

On July 10, 2007, Qwest filed an application in Docket C-3829 seeking Commission approval of certain revisions to its Statement of Generally Available Terms (SGAT). The revisions to the SGAT for which Qwest seeks Commission approval include changes to Exhibit B and Exhibit K of the SGAT. Exhibit B and Exhibit K contain Qwest Service Performance Indicators and Qwest Performance Assurance Plan provisions respectively.

An executed copy of the agreement entered into by Qwest and NOS is contained within the application in the above-captioned docket. Part of the agreement contains portions of the latest revision to the SGAT, including Exhibit B and Exhibit K, at issue in Docket C-3829. Therefore, the Commission entered an order on October 10, 2007 staying any further proceedings in the above-captioned docket until the Commission made a determination in Docket C-3829. Subsequently, the Commission entered an order in Docket C-3829 allowing the proposed revisions to Qwest's SGAT to become effective. Hence, we find that the stay imposed by this Commission is hereby lifted.

Pursuant to Section 252(a) of the Telecommunications Act of 1996 (the Act), Qwest and NOS entered into a New Resale Interconnection Agreement arrived at through voluntary negotiations.
