## BY THE COMMISSION:

By application filed August 20, 2007, Qwest Corporation (Qwest) of Denver, Colorado, and NOS Communications, Inc., (NOS) of Las Vegas, Nevada, seeking approval of their voluntarily negotiated Interconnection Agreement. Notice of the application was published in <a href="https://doi.org/10.1007/jheps.com/">The Daily Record, Omaha, Nebraska, on August 24, 2007.</a>

On July 10, 2007, Qwest filed an application in Docket C-3829 seeking Commission approval of certain revisions to its Statement of Generally Available Terms (SGAT). The revisions to the SGAT for which Qwest seeks Commission approval include changes to Exhibit B and Exhibit K of the SGAT. Exhibit B and Exhibit K contain Qwest Service Performance Indicators and Qwest Performance Assurance Plan provisions respectively. Docket C-3829 is pending before this Commission and the Commission has not made a decision concerning the changes to the SGAT that Qwest proposes.

An executed copy of the agreement entered into by Qwest and NOS is contained within the application in the above-captioned docket. Part of the agreement contains portions of the SGAT, including Exhibit B and Exhibit K. However, the Exhibit B and Exhibit K submitted by Qwest and NOS as part of their Interconnection Agreement contain the revised versions of these exhibits that are pending Commission approval under Docket C-3829.

As a determination in Docket C-3829 is currently pending before this Commission, we find the Commission should defer making a decision regarding approval of the

Interconnection Agreement between Qwest and NOS in the above-captioned docket pending a determination in Docket C-3829. To enter an order approving the Interconnection Agreement in this docket before a determination was reached in Docket C-3829, would effectively render a Commission decision on the changes to the SGAT at issue in Docket C-3829, moot.

Therefore, further Commission action in the above-captioned docket shall be stayed pending a Commission determination on the revisions to the SGAT proposed by Owest in Docket C-3829.

## ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the proceedings in the above-captioned docket, be, and are hereby stayed, pending an order by the Commission in Docket C-3829 containing a determination on the proposed revisions to the SGAT.
