OPINION AND FINDINGS

On December 4, 2007, the Nebraska Public Service Commission ("Commission") granted the application of Geneva Broadband, LLC, ("GBB"), Geneva, Nebraska, authorizing GBB to provide competitive local exchange service within the State of Nebraska. It its application, GBB indicated that at some point in the future it would install and utilize its own facilities, but at the time of the application its immediate plans were to use resold facilities.

On April 21, 2008, the Commission received a letter from GBB stating that the company intends to begin offering facilities-based services in its authorized service areas and requesting that the Commission clarify GBB's authority under it's CLEC certificate.

The original grant of authority by the Commission in Application No. C-3872 referenced only resold, non-facilities based services. However, the requirements to receive a grant of authority from the Commission to operate as a local exchange carrier within Nebraska are the same for both resale and facilities-based carriers. It is Commission policy to make no distinction between certificates of authority for either facilities-based or resale local exchange carriers.

Since the GBB has indicated plans to move forward with facilities-based services, we find that GBB's request should be granted and the Commission hereby clarifies that the grant of authority under Application No. C-3872 includes the authority to provide facilities-based services as well as resold services.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the request by Geneva Broadband, LLC, for clarification of its CLEC authority be, and is hereby granted, and Geneva Broadband, LLC, is authorized to provide both

facilities-based and resold services in its authorized service area.
