### BY THE COMMISSION:

By application filed December 4, 2007, Cognigen Networks, Inc., (Cognigen) Mountlake Terrace, Washington, is seeking authority to cancel its certificate of authority to provide interexchange telecommunications services in the State of Nebraska, previously approved in Docket C-2965. Notice of the application was published in <a href="The Daily Record">The Daily Record</a>, Omaha, Nebraska, on December 18, 2007. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

# OPINION AND FINDINGS

On June 12, 2003, Cognigen was granted authority to operate as an interexchange telecommunications carrier within the State of Nebraska pursuant to Docket C-2965.

By application received on December 4, 2007, Cognigen requested the cancellation of its authority to operate as an interexchange carrier of telecommunications services in the State of Nebraska. Cognigen no longer has customers and does not provide telecommunications service in Nebraska.

Upon consideration of the request and being fully advised, the Commission finds the request to be reasonable and finds that Cognigen's authority to operate as an interexchange carrier of telecommunications services in the State of Nebraska should be cancelled.

## ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-3890 be, and it is hereby, granted and the Certificate of Public Convenience and Necessity to provide interexchange telecommunications services previously granted to Cognigen Networks, Inc., is cancelled.
