By application filed December 12, 2007, United Telephone Company of the West d/b/a Embarq (Embarq), Overland Park, Kansas, is seeking approval of a Master Resale Agreement with Ernest Communications Inc. (Ernest), Norcross, Georgia. Notice of the application was published in The Daily Record, Omaha, Nebraska, on December 17, 2007. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.
