BY THE COMMISSION:

By application filed December 17, 2007, Computer Network Technology Corporation (CNT), Minneapolis, Minnesota, is seeking authority to cancel its certificate of authority to provide local exchange and interexchange telecommunications services in the State of Nebraska, previously approved in Docket C-3053, and to cancel its tariffs. Notice of the application was published in The Daily Record, Omaha, Nebraska, on December 19, 2007. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N A N D F I N D I N G S

On January 13, 2004, CNT was granted authority to operate as a local exchange and interexchange telecommunications carrier within the state of Nebraska pursuant to Docket C-3053.

By application received on December 17, 2007, CNT requested the cancellation of its authority to operate as a local exchange and interexchange carrier of telecommunications services in the State of Nebraska. CNT serves no customers and does not provide telecommunications service in Nebraska.

Upon consideration of the request and being fully advised, the Commission finds the request to be reasonable and finds that CNT's authority to operate as a local exchange and interexchange carrier of telecommunications services in the State of Nebraska should be cancelled and its tariffs withdrawn.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-3894 be, and it is hereby, granted and the Certificate of Public Convenience and Necessity to provide local exchange and interexchange telecommunications services previously granted to Computer Network Technology Corporation, is cancelled.

IT IS FURTHER ORDERED that Computer Network Technology Corporation's local exchange and interexchange tariffs be, and are hereby, withdrawn.

IT IS FURTHER ORDERED that Computer Network Technology Corporation's local exchange and interexchange tariffs be, and are hereby, withdrawn.


