OPINION AND FINDINGS

On January 25, 2008, an application was filed by Qwest Corporation (Qwest), of Denver, Colorado, seeking approval of an amendment to the Interconnection Agreement with Iowa Wireless Services LLC d/b/a i Wireless, (i Wireless), Urbandale, Iowa, which was previously approved by the Commission in Docket C-3599. Notice of the application was published in The Daily Record, Omaha, Nebraska, on January 31, 2008. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

July 5, 2006, in Docket C-3599, the original interconnection agreement between Qwest and i Wireless approved by the Commission. In the current application, Qwest seeks to amend the agreement by adding a Single Point Presence (SPOP) Amendment to the Interconnection Agreement. copy of the amendment is contained within executed the application.

The amendment does not discriminate against any telecommunications carrier that is not a party to the agreement. Furthermore, the implementation of the amendment is consistent with the public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review negotiated interconnection agreements to ensure they comply with Sections 251 and 252(d) of the Act, as well as all applicable state laws. Using those standards, the amendment filed January 25, 2008, should be approved.
