BY THE COMMISSION:

On January 25, 2008, an application was filed by Windstream Nebraska, Inc., (Windstream) Little Rock, Arkansas, seeking arbitration of an Interconnection Agreement between Alltel Communications, Inc., (Alltel) Little Rock, Arkansas. Windstream and Alltel reached a negotiated agreement, executed February 19, 2008. Notice of the application was published in The Daily Record, Omaha, Nebraska, on January 31, 2008, and again on February 24, 2008. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Pursuant to Section 252(a) of the Telecommunications Act of 1996 (the Act), Windstream and Alltel entered into an Interconnection Agreement arrived at through voluntary negotiations. An executed copy of this agreement is contained within the application. There are no outstanding issues relating to the agreement that require the assistance of mediation or arbitration.

Neither the Agreement nor any portion thereof discriminates against any telecommunications carrier. Furthermore, the implementation of the agreement is consistent with the public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review interconnection agreements adopted by negotiation or arbitration to ensure they comply with Sections 251 and 252(d) of the Act, as well as all applicable state laws. Using those standards, the Interconnection Agreement should be approved.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the Interconnection Agreement between Windstream and Alltel, be, and it is hereby, approved.
