### BY THE COMMISSION:

By application filed February 11, 2008, New Century Telecom, Inc., (New Century) Roswell, Georgia, is seeking authority to withdraw its certificate of authority to provide interexchange telecommunications services in the State of Nebraska, previously approved in Docket C-1789, and to cancel its tariffs. Notice of the application was published in The Daily Record, Omaha, Nebraska, on February 22, 2008. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

## OPINION AND FINDINGS

On June 16, 1998, New Century was granted authority to operate as an interexchange telecommunications carrier within the state of Nebraska pursuant to Docket C-1789.

By application received on February 11, 2008, New Century requested the withdrawal of its authority to operate as an interexchange carrier of telecommunications services in the State of Nebraska. New Century serves no customers and does not provide telecommunications service in Nebraska.

Upon consideration of the request and being fully advised, the Commission finds the request to be reasonable and finds that New Century's authority to operate as an interexchange carrier of telecommunications services in the State of Nebraska should be cancelled and its tariffs withdrawn.

# ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-3906 be, and it is hereby, granted and the Certificate of Public Convenience and Necessity to provide interexchange telecommunications services previously granted to New Century Telecom, Inc., is cancelled.

IT IS FURTHER ORDERED that any New Century Telecom, Inc. interexchange tariffs be, and are hereby, withdrawn.
