BY THE COMMISSION:

By application filed February 14, 2008, Budget Prepay, Inc. d/b/a Budget Phone (Budget), Bossier City, Louisiana, is seeking authority to withdraw its certificates of authority to provide local exchange and interexchange telecommunications services in the State of Nebraska, previously approved in Docket C-2771. Notice of the application was published in The Daily Record, Omaha, Nebraska, on March 13, 2008. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N A N D F I N D I N G S

On September 11, 2002, Budget was granted authority to operate as a local exchange and interexchange telecommunications carrier within the State of Nebraska pursuant to Docket C-2771.

By application received on February 14, 2008, Budget requested the withdrawal of its authority to operate as a local exchange and interexchange carrier of telecommunications services in the State of Nebraska. Budget provides prepaid services to a small number of customers in Nebraska and has determined it is no longer profitable for the company to continue to conduct business in Nebraska.

Upon consideration of the request and being fully advised, the Commission finds the request to be reasonable and finds that Budget's authority to operate as a local exchange and interexchange carrier of telecommunications services in the State of Nebraska should be withdrawn.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-3912 be, and it is hereby, granted and the Certificate of Public Convenience and Necessity to provide local exchange and interexchange telecommunications

services previously granted to Budget Prepay, Inc., d/b/a Budget Phone, is withdrawn.




