BY THE COMMISSION:

By application filed March 13, 2008, Fast Phones of Nebraska, Corp. (Fast Phones), Lincoln, Nebraska, is seeking authority to withdraw its certificate of authority to provide local exchange telecommunications services in the State of Nebraska, previously approved in Docket C-2526. Notice of the application was published in The Daily Record, Omaha, Nebraska, on March 14, 2008. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N A N D F I N D I N G S

On August 21, 2001, Fast Phones was granted authority to operate as a local exchange telecommunications carrier within the State of Nebraska pursuant to Docket C-2526.

By application received on March 13, 2008, Fast Phones requested the withdrawal of its authority to operate as a local exchange carrier of telecommunications services in the state of Nebraska. Fast Phones provides prepaid services to a small number of customers in Nebraska and has determined it is no longer profitable to the company to continue to conduct business in Nebraska.

Upon consideration of the request and being fully advised, the Commission finds the request to be reasonable and finds that Fast Phones' authority to operate, as a local exchange carrier of telecommunications services in the State of Nebraska should be withdrawn along with its tariff.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-3918 be, and it is hereby, granted and the Certificate of Public Convenience and Necessity to provide local exchange telecommunications services previously granted to Fast Phones of Nebraska, Corp., is withdrawn.
