BY THE COMMISSION:

By application filed March 7, 2008, CTC Communications Corp., of Waltham, Massachusetts, is seeking authority to withdraw its certificate of authority to provide interexchange telecommunications services in the State of Nebraska, previously approved in Docket C-1883, and to cancel its tariffs. Notice of the application was published in The Daily Record, Omaha, Nebraska, on March 14, 2008. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N     A N D     F I N D I N G S

On October 7, 1998, CTC Communications Corp., was granted authority to operate as an interexchange telecommunications carrier within the State of Nebraska pursuant to Docket C-1889.

By application received on March 7, 2008, CTC Communications Corp. requested authority to withdraw its authority to operate as an interexchange carrier of telecommunications services in the State of Nebraska. CTC Communications Corp. has not actively marketed its services in Nebraska and has provided only incidental service in the state.

Upon consideration of the request and being fully advised, the Commission finds the request to be reasonable and finds that CTC Communications Corp.'s authority to operate as an interexchange carrier of telecommunications services in the State of Nebraska should be cancelled and its tariffs withdrawn.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-3919 be, and it is hereby, granted and the Certificate of Public Convenience and Necessity to provide interexchange telecommunications services previously granted to CTC Communications Corp. is cancelled.

IT IS FURTHER ORDERED that the interexchange tariffs on file for CTC Communications Corp. be, and are hereby, withdrawn.
