BY THE COMMISSION:

By application filed April 28, 2008, Western CLEC Corporation ("Western"), Lincoln, Nebraska, is seeking authority to withdraw its certificate of authority to provide local exchange telecommunications services in the State of Nebraska, previously approved in Docket C-1760, and to cancel its tariffs. Notice of the application was published in The Daily Record, Omaha, Nebraska, on May 8, 2008. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N A N D F I N D I N G S

On June 9, 1998, Western was granted authority to operate as a local exchange telecommunications carrier within the State of Nebraska pursuant to Docket C-1760.

By application received on April 28, 2008, Western requested the withdrawal of its authority to operate as a local exchange carrier of telecommunications services in the State of Nebraska. Western has no customers or operations in Nebraska.

Upon consideration of the request and being fully advised, the Commission finds the request to be reasonable and finds that Western's authority to operate as a local exchange carrier of telecommunications services in the State of Nebraska should be cancelled and its tariff withdrawn.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-3930 be, and it is hereby, granted and the Certificate of Public Convenience and Necessity to provide local exchange telecommunications services previously granted to Western CLEC Corporation, is cancelled.

IT IS FURTHER ORDERED that any Western CLEC Corporation local exchange tariffs be, and are hereby, withdrawn.
