BY THE COMMISSION:

By application filed May 12, 2008, Qwest Corporation (Qwest) of Denver, Colorado, seeks approval of a Wireless Originated 8XX Jointly Provided Switched Access Amendment to the Interconnection Agreement with TCG Omaha, (CLEC) Douglasville, Georgia previously granted in Docket C-3095. Notice of the application was published in The Daily Record, Omaha, Nebraska, on May 16, 2008. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Pursuant to Section 252(a) of the Telecommunications Act of 1996 (the Act), Qwest and CLEC (parties) entered into an Interconnection Agreement arrived at through voluntary negotiations and previously granted in Docket C-3095. The parties now wish to amend the agreement further through a Wireless Originated 8XX Jointly Provided Switched Access Amendment. An executed copy of this amendment is contained within the application.

Neither the amendment nor any portion thereof discriminates against any telecommunications carrier. Furthermore, the implementation of the amendment is consistent with the public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review interconnection agreements adopted by negotiation or arbitration to ensure they comply with Sections 251 and 252(d) of the Act, as well as all applicable state laws. Using those standards, the Wireless Originated 8XX Jointly Provided Switched Access Amendment to the Interconnection Agreement should be approved.
