By application filed May 12, 2008, Qwest Corporation (Qwest) of Denver, Colorado, seeks approval of a Wireless Originated 8XX Jointly Provided Switched Access Amendment to the Interconnection Agreement with New Cingular Wireless PCS, LLC, (fka AT&T Wireless PCS, Inc.)(New Cingular) Redmond, Washington, previously approved in Docket C-2100. Notice of the application was published in The Daily Record, Omaha, Nebraska, on May 16, 2008.
