BY THE COMMISSION:

By application filed July 9, 2008, Global Connection, Inc. of America d/b/a GCIA Corp. (GCIA), Atlanta, Georgia, seeks approval of a Resale Agreement with United Telephone of the West d/b/a Embarq (Embarq), Salt Lake City, Utah. Notice of the application was published in The Daily Record, Omaha, Nebraska, on July 11, 2008. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Pursuant to Section 252(a) of the Telecommunications Act of 1996 (the Act), GCIA and Embarq entered into a Resale Agreement arrived at through voluntary negotiations. An executed copy of this agreement is contained within the application.

Neither the agreement nor any portion thereof discriminates against any telecommunications carrier. Furthermore, the implementation of the agreement is consistent with the public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review resale agreements adopted by negotiation or arbitration to ensure they comply with Sections 251 and 252(d) of the Act, as well as all applicable state laws. Using those standards, the resale agreement should be approved.

## ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the Resale Agreement between Global Connection, Inc. of America d/b/a GCIA Corp. and United Telephone of the West d/b/a Embarq, be, and it is hereby, approved.
