OPINION AND FINDINGS

On July 22, 2008, an application was filed by Qwest Corporation (Qwest), of Denver, Colorado, seeking approval of an amendment to the Interconnection Agreement with 360networks(USA)inc., (360networks), Seattle, Washington, which was previously approved by the Commission in Docket C-3601. Notice of the application was published in The Daily Record, Omaha, Nebraska, on July 25, 2008. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

July 5, 2006, in Docket C-3601, the On original Interconnection Agreement between Qwest and 360networks was In the current application, Qwest approved by the Commission. seeks to amend the agreement by adding a transit rate calculation amendment to the Interconnection Agreement. An executed copy of the amendment is contained within the application.

The amendment does not discriminate against any telecommunications carrier that is not a party to the agreement. Furthermore, the implementation of the amendment is consistent with the public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review negotiated interconnection agreements to ensure they comply with Sections 251 and 252(d) of the Act, as well as all applicable state laws. Using those standards, the amendment filed July 22, 2008, should be approved.
