BY THE COMMISSION:

By application filed August 4, 2008, Network PTS, Inc. ("Network"), Danville, California, is seeking authority to withdraw its certificate of authority to provide interexchange telecommunications services in the State of Nebraska, previously approved in Docket C-3422, and to cancel its tariffs. Notice of the application was published in The Daily Record, Omaha, Nebraska, on August 5, 2008. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N     A N D     F I N D I N G S

On July 12, 2005, Network was granted authority to operate as an interexchange telecommunications carrier within the State of Nebraska pursuant to Docket C-3422.

By application received on August 4, 2008, Network requested the withdrawal of its authority to operate as an interexchange carrier of telecommunications services in the State of Nebraska. Network has no customers or operations in Nebraska.

Upon consideration of the request and being fully advised, the Commission finds the request to be reasonable and finds that Network's authority to operate as an interexchange carrier of telecommunications services in the State of Nebraska should be cancelled and its tariff withdrawn.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-3953 be, and it is hereby, granted and the certificate of authority to provide interexchange telecommunications services previously granted to Network PTS, Inc., is cancelled.

IT IS FURTHER ORDERED that any Network PTS, Inc. interexchange tariffs be, and are hereby, withdrawn.
