## BY THE COMMISSION:

By application filed September 10, 2008, Hamilton Telephone Company (Hamilton), Aurora, is seeking approval of an Extended Area Service Agreement with Charter Fiberlink-Nebraska, LLC (Charter), St. Louis, Missouri. Notice of the application was published in <a href="The Daily Record">The Daily Record</a>, Omaha, Nebraska, on September 15, 2008. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Pursuant to Section 252(a) of the Telecommunications Act of 1996 (the Act), Hamilton and Charter entered into an Extended Area Service agreement arrived at through voluntary negotiations. An executed copy of this agreement is contained within the application.

Neither the agreement nor any portion thereof discriminates against any telecommunications carrier. Furthermore, the implementation of the agreement is consistent with public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review service agreements adopted by negotiation or arbitration to ensure they comply with Sections 251 and 252(d) of the Act, as well as all applicable state laws. Using those standards, the service agreement should be approved.
