BY THE COMMISSION:

On June 8, 2010, an application was jointly filed by ALEC, Inc. ("ALEC"), of Lexington, Kentucky, SinglePipe Communications, Inc. ("SinglePipe"), of Louisville, Kentucky, and Integrated Broadband Services, LLC ("IBBS") of Kennesaw, Georgia, (collectively "Applicants"), seeking approval of a transfer control of ALEC to IBBS. Notice of the application was published in The Daily Record, Omaha, Nebraska, on June 11, 2010. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

OPINION AND FINDINGS

The Parties:

ALEC is a Kentucky corporation with principal offices located in Lexington, Kentucky. ALEC is a wholly owned subsidiary of SinglePipe, a Kentucky corporation with principal offices located in Louisville, Kentucky. ALEC provides local exchange, interexchange, and other telecommunications services in Nebraska under and by virtue of authority heretofore granted by this Commission. ALEC currently has one business customer in Nebraska.

IBBS is a limited liability company with its principal place of business located in Kennesaw, Georgia. IBBS provides operational support software and back office services for cable and broadband operators. IBBS is not a regulated telecommunications entity in Nebraska or any other state, and has no affiliates or subsidiaries that are regulated telecommunications entities.

Description of the Transaction:

According to the application, pursuant to a Letter of Intent to Purchase ("LOI") signed on June 4, 2010, IBBS will acquire 100% of the equity interests in SinglePipe. The Applicants state that the transaction is in the public interest and will benefit the customers of ALEC because it will stabilize ALEC's financial and operational standing in Nebraska.

Based on the evidence, we find the application to be fair and reasonable and in the public interest. The application should be granted.
