BY THE COMMISSION:

By application filed October 17, 2008, Integra Telecom of Nebraska, Inc., (Integra), Minneapolis, Minnesota, is seeking authority to withdraw its certificates of authority to provide local exchange and interexchange telecommunications services in the state of Nebraska, previously approved in Docket C-2174 and C-2236 respectively. Notice of the application was published in The Daily Record, Omaha, Nebraska, on October 23, 2008. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N     A N D     F I N D I N G S

On March 28, 2000, Integra was granted authority to operate as a local exchange telecommunications carrier within the state of Nebraska pursuant to Docket C-2174. On April 11, 2000, Integra was granted authority to operate as an interexchange telecommunications carrier in the State of Nebraska pursuant to Docket C-2236.

By application received on October 17, 2008, Integra requested the withdrawal of both certificates of authority to operate as a local exchange and interexchange carrier of telecommunications services in the State of Nebraska. Integra is not providing any service to customers in Nebraska currently and has no plans to offer service in Nebraska in the future.

Upon consideration of the request and being fully advised, the Commission finds the request to be reasonable and finds that Integra's authority to operate as a local exchange and interexchange carrier of telecommunications services in the State of Nebraska should be withdrawn along with its tariffs.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-3980 be, and it is hereby, granted and the Certificates of Public Convenience and Necessity to provide local exchange and interexchange telecommunications services previously granted to Integra Telecom of Nebraska, Inc., are withdrawn.



O R D E R


