BY THE COMMISSION:

By application filed November 25, 2008, D.D.D. Calling, Inc., (D.D.D.) Houston, Texas, is seeking authority to withdraw its certificate of authority to provide local exchange telecommunications services in the State of Nebraska, previously approved in Docket C-1336, and to cancel its tariffs. Notice of the application was published in The Daily Record, Omaha, Nebraska, on December 2, 2008. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N A N D F I N D I N G S

On August 20, 1996, D.D.D. was granted authority to operate as an resold local exchange and interexchange telecommunications carrier within the state of Nebraska pursuant to Docket C-1336.

By application received on November 25, 2008, D.D.D. requested the withdrawal of its authority to operate as a carrier of telecommunications services in the State of Nebraska. D.D.D. serves no customers and does not provide telecommunications service in Nebraska.

Upon consideration of the request and being fully advised, the Commission finds the request to be reasonable and finds that D.D.D.'s authority to operate as an local exchange and interexchange carrier of telecommunications services in the state of Nebraska should be cancelled and its tariffs withdrawn.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-3992 be, and it is hereby, granted and the Certificate of Public Convenience and Necessity to provide local exchange and interexchange telecommunications services previously granted to D.D.D. Calling, Inc., is cancelled.

IT IS FURTHER ORDERED that any D.D.D. Calling, Inc. tariffs be, and are hereby, withdrawn.
