By application filed November 26, 2008, Qwest Corporation (Qwest) of Denver, Colorado, seeks approval of a Collocation Bay Procurement Amendment to the Interconnection Agreement with XO Communications Services, Inc., (CLEC) Salt Lake City, Utah, previously granted in Docket C-3939. Notice of the application was published in The Daily Record, Omaha, Nebraska, on December 12, 2008. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.
