BY THE COMMISSION:

By application filed December 1, 2008, Phonel, Inc., (Phonel) Bay Harbor Island, Florida, is seeking authority to withdraw its certificate of authority to provide interexchange telecommunications services in the State of Nebraska, previously approved in Docket C-3299 and to cancel its tariffs. Notice of the application was published in The Daily Record, Omaha, Nebraska, on December 4, 2008. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

OPINION AND FINDINGS

On December 14, 2004, Phonel was granted authority to operate as an interexchange telecommunications carrier within the State of Nebraska pursuant to Docket C-3299.

By application received on December 1, 2008, Phone1 requested the withdrawal of its authority to operate as an interexchange carrier of telecommunications services in the State of Nebraska. Phone1 serves no customers and does not provide telecommunications service in Nebraska.

Upon consideration of the request and being fully advised, the Commission finds the request to be reasonable and finds that Phonel's authority to operate as an interexchange carrier of telecommunications services in the State of Nebraska should be cancelled and its tariffs withdrawn.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-3994 be, and it is hereby, granted and the Certificate of Public Convenience and Necessity to provide interexchange telecommunications services previously granted to Phonel, Inc., is cancelled.

IT IS FURTHER ORDERED that any Phonel, Inc. tariffs be, and are hereby, withdrawn.
