First Call for Help, a program of the United Way of Midlands Volunteer Resource Center, is a comprehensive information and referral service.

In order to proceed on this request, this docket will evaluate the public benefits of designating "211" for York County. The Commission will hold a hearing on this matter on a date later if necessary.


