Notice of the application was published in The Daily Record, Omaha, Nebraska, on December 30, No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

OPINION AND FINDINGS

On October 24, 1997, LDMI was granted authority to operate as an interexchange telecommunications carrier within the state of Nebraska pursuant to Docket C-1672.

By application received on December 23, 2008, LDMI requested the withdrawal of its certificate of authority to operate as an interexchange carrier of telecommunications services in the State of Nebraska. LDMI is not providing any service to customers in Nebraska currently and has no plans to offer service in Nebraska in the future.

Upon consideration of the request and being fully advised, the Commission finds the request to be reasonable and finds that LDMI's authority to operate as an interexchange carrier of telecommunications services in the state of Nebraska should be withdrawn along with its tariffs.
