BY THE COMMISSION:

By application filed May 25, 2012, DSLnet Communications, LLC (DSLnet), Austin, Texas, is seeking authority to withdraw its certificate of authority to provide local exchange and interexchange telecommunications services in the State of Nebraska, previously approved in Docket C-3859. Notice of the application was published in The Daily Record, Omaha, Nebraska, on June 1, 2012. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

OPINION AND FINDINGS

On May 26, 1999, DSLnet was granted authority to provide resold and facilities-based interexchange telecommunications services within the State of Nebraska pursuant to Docket C-2031. On June 15, 1999, DSLnet was granted further authority to operate as a competitive local exchange carrier in Nebraska pursuant to Docket C-2032.

By application received on May 25, 2012, DSLnet requested the withdrawal of its authority to operate as an exchange and interexchange carrier of telecommunications services in the State of Nebraska. DSLnet merged with and into DIECA Communications, Inc. d/b/a Covad Communications Company on December 31, 2011, and is no longer providing or billing customers for local exchange or interexchange services in the State of Nebraska.

Upon consideration of the request and being fully advised, the Commission finds the request to be reasonable and finds that DSLnet's authority to provide local exchange and interexchange telecommunications services in the State of Nebraska should be cancelled and its tariffs withdrawn.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-4052.1 be, and it is hereby, granted and the Certificate of Public Convenience and Necessity to provide local exchange and interexchange telecommunications
