On January 20, 2009, an application was filed by Inter-Tel NetSolutions, Inc. ("Inter-Tel") of Phoenix, Arizona, seeking authority to change its name to Mitel NetSolutions, Inc. Notice of the application was published in The Daily Record, Omaha, Nebraska, on January 22, 2009. No protests were filed; therefore, we process this application pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N A N D F I N D I N G S

Inter-Tel is a corporation with its principal offices located at 4310 East Cotton Center Blvd., Ste. A-100, Phoenix, Arizona, 85040. Inter-Tel operates pursuant to a certificate of public convenience and necessity issued by this Commission June 25, 1996 under Docket C-1295 and is subject to the jurisdiction of this Commission.

In the present application, Inter-Tel requests that the Commission enter an order approving the adoption by Inter-Tel of the name "Mitel NetSolutions, Inc.". Inter-Tel has received authority from the Secretary of State to use the new name. The adoption of the new name will have no effect on the rates, terms or conditions of Inter-Tel's provision of telecommunications services to its customers. Based on the all the evidence adduced, the Commission is of the opinion the application is in the public interest and should be granted.

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-4136 be, and it is hereby, granted and the request of Inter-Tel NetSolutions, Inc. to change its name to Mitel NetSolutions, Inc. is approved.
