By application filed January 20, 2009, Charter Fiberlink-Nebraska, LLC (Charter) of St. Louis, Missouri, seeks approval of an Extended Area Service Agreement with The Glenwood Telephone Membership Corporation, (Glenwood) of Blue Hill, Nebraska. Notice of the application was published in <a href="The Daily Record">The Daily Record</a>, Omaha, Nebraska, on January 22, 2009. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.
