BY THE COMMISSION:

On January 30, 2009, a joint application was filed by Windstream Nebraska, Inc. (Windstream) of Little Rock, Arkansas, and Bandwidth.com CLEC, LLC (Bandwidth.com) of Cary, North Carolina, seeking approval of their interconnection agreement as amended, pursuant to 47 U.S.C. §252(i). Notice of the application was published in The Daily Record, Omaha, Nebraska, on February 11, 2009. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Section 252(i) of the Telecommunications Act of 1996 allows any telecommunications carrier to adopt a Commission-approved interconnection agreement. Windstream wishes to establish an interconnection agreement with Bandwidth.com and accordingly seeks to adopt the Level 3 interconnection agreement as amended. The Level 3 agreement was approved by the Commission pursuant to Docket C-2964 on July 15, 2003.

On May 28, 1997, the Commission added language to its mediation/arbitration policy (see Docket C-1128, Progression Order No. 3) which sets forth the procedures to be followed for a Section 252(i) request. Windstream and Bandwidth.com have sufficiently complied with the procedures required by the Commission's policy.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-4142 be, and it is hereby, approved and Windstream Nebraska, Inc. and Bandwidth.com CLEC, LLC are hereby authorized to adopt the voluntarily-negotiated interconnection agreement between Windstream Nebraska, Inc. and Level 3 Communications, LLC as amended.

IT IS FURTHER ORDERED that Windstream Nebraska, Inc. and Bandwidth.com CLEC, LLC's adoption of the amended Level 3 agreement became effective February 25, 2009.





