OPINION AND FINDINGS

On February 10, 2009, an application was filed by Windstream Nebraska, Inc. (Windstream), of Little Rock, Arkansas, seeking approval of an Amendment to the Interconnection Agreement with MCImetro Access Transmission Services, LLC (MCI) which was previously approved by the Commission in Application No. C-3507. Notice of the application was published in The Daily Record, Omaha, Nebraska, on February 12, 2009. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

On January 11, 2006, in Application No. C-3507, the original interconnection agreement between Windstream and MCI was approved by the Commission. In the current application, Windstream seeks to amend the agreement by adding terms and conditions for the compensation of Local Traffic and ISP-Bound Traffic to the Interconnection Agreement. An executed copy of the amendment is contained within the application.

The amendment does not discriminate against any telecommunications carrier that is not a party to the agreement. Furthermore, the implementation of the amendment is consistent with the public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review negotiated interconnection agreements to ensure they comply with Sections 251 and 252(d) of the Act, as well as all applicable state laws. Using those standards, the amendment filed February 10, 2009, should be approved.
