On February 20, 2009, an Application was filed by McLeodUSA Telecommunications Services, Inc. (McLeodUSA), Hiawatha, Iowa, seeking authority to add the following d/b/a name, PAETEC Business Services. Notice of the application was published in The Daily Record, Omaha, Nebraska, on March 4, 2009. No protests were filed; therefore, we process this application pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N A N D F I N D I N G S

McLeodUSA is authorized to operate as a competitive local exchange carrier pursuant to an order issued by this Commission November 13, 1999 under Docket C-1932 and is subject to the jurisdiction of this Commission.

In the present Application, McLeodUSA requests that the Commission enter an order approving the adoption by McLeodUSA of the d/b/a name "PAETEC Business Services". McLeodUSA has received authority from the Secretary of State to use the new trade name. The adoption of the new trade name will have no effect on the rates, terms or conditions of McLeodUSA's provision of telecommunications services to its customers. Based on the all the evidence adduced, the Commission is of the opinion the application is in the public interest and should be granted.

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-4146 be, and it is hereby, granted and the request of McLeodUSA Telecommunications Services, Inc. to add PAETEC Business Services as a d/b/a name is approved.

IT IS FURTHER ORDERED that the applicant file an updated tariff reflecting the change in name within 30 days of the date of this order.
