# OPINION AND FINDINGS

Pursuant to the Nebraska Telecommunications Regulation Act1 ("Telecom Act"), prior to offering any telecommunications service in the state of Nebraska, telecommunications providers shall obtain a Certificate of Public Convenience and Necessity from the Nebraska Public Service Commission ("Commission"). Neb. Rev. Stat. § 86-128(1)(a), states, "a person shall file an application and receive either a certificate of convenience and necessity as a telecommunications common carrier or a permit as a telecommunications contract carrier before such person may offer any telecommunications service."2 The Commission has promulgated rules regulations containing and application requirements for any carrier desiring to receive a Certificate of Public Convenience and Necessity from the Commission prior to operating as a provider of telecommunications services within the State of Nebraska.

Norstan Network Services, Inc., ("Norstan"), received a Certificate of Public Convenience and Necessity to provide interexchange telecommunications service in the state of Nebraska in 1992. Norstan's Certificate of Authority to operate in Nebraska was revoked by the Commission in 2005 for failure to file an annual report consistent with statutory requirements.

The Commission received Nebraska Universal Service Fund ("NUSF") worksheets and payments in 2008 indicating that Norstan is providing telecommunications services in Nebraska. On August 27, 2008, telephone contact was made with Mr. Rafael Vanegas, an employee of Norstan, regarding the Company's operations Nebraska without a Certificate of Authority by Commission Staff. Mr. Vanegas assured Commission Staff that Norstan would submit an application for authority to the Commission immediately to come into compliance with Nebraska Law and Commission rules and regulations. Copies application forms of were sent electronic mail to Mr. Vanegas the same day. No response was received from Norstan, and a subsequent email request by staff on September 24, 2008 went unanswered as well.

On November 3, 2008, the Director of the Commission's Communications Department, Gene Hand, sent a letter to Norstan giving the company until December 3, 2008, to submit application for authority or cease operations in Nebraska. 20, 2009, the Commission received an incomplete for authority from Norstan with insufficient application information to process the application. After repeated attempts to contact Norstan by Staff, an email response from Mr. Vanegas received on January 28, 2009, indicated the company would file a completed application. The Commission has received no further contact from Norstan regarding the application for authority. The Commission did receive NUSF worksheets for the Forth Quarter, 2008 in January, 2009, and First Quarter 2009 in April 2009 indicating that Norstan continues to telecommunications services and conduct business in Nebraska.

Accordingly, the Commission finds it appropriate initiate a Show Cause proceeding requiring Norstan Network Service, Inc. to appear before the Commission at 300 The Atrium Building, 1200 N Street, Lincoln, Nebraska on June 23, 2009, at 1:30 p.m. CDT and show cause why the Commission should not order Norstan to immediately cease and desist operations in Nebraska why the Commission should not impose administrative penalties against it pursuant to Neb. Rev. Stat. S of 2008) for operating in Nebraska without (Reissue Certificate of Public Convenience and Necessity.

# ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Norstan Network Service, Inc., be and is hereby ordered, to show cause why the Commission should not order Norstan to immediately cease and desist operations in Nebraska and assess upon said company administrative penalties for illegally operating in Nebraska without a Certificate of Public Convenience and Necessity.

IT IS FURTHER ORDERED that Norstan Network Services, Inc. appear before the Commission on **June 23, 2009,** at 1:30 p.m. CDT, in the Commission Hearing Room, 300 The Atrium Building, 1200 N Street, Lincoln, Nebraska, for a hearing on this Show Cause Order.
