BY THE COMMISSION:

By application filed March 20, 2009, NexUSTel, LLC, (NexUSTel) Miami, Florida, is seeking authority to withdraw its certificate of authority to provide interexchange telecommunications services in the State of Nebraska, previously approved in Docket No. C-3940. Notice of the application was published in The Daily Record, Omaha, Nebraska, on May 13, 2009. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N A N D F I N D I N G S

On August 12, 2008, NexUSTel was granted authority to operate as an interexchange telecommunications carrier within the State of Nebraska pursuant to Docket C-3940.

By application received on March 20, 2009, NexUSTel requested the withdrawal of its authority to operate as a carrier of interexchange telecommunications services in the State of Nebraska. NexUSTel does not currently provide and does not plan to provide long distance service in the foreseeable future.

Upon consideration of the request and being fully advised, the Commission finds the request to be reasonable and finds that NexUSTel's authority to operate as an interexchange carrier of telecommunications services in the State of Nebraska should be cancelled and its tariff withdrawn.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-4169 be, and it is hereby, granted and the Certificate of Public Convenience and Necessity to provide interexchange telecommunications services previously granted to NexUSTel, LLC, is cancelled.

IT IS FURTHER ORDERED that any NexUStel, LLC tariffs be, and are hereby, withdrawn.
