## BY THE COMMISSION:

By application filed March 12, 2009, Protocall LLC, (Protocall) Olathe, Kansas, is seeking authority to withdraw its certificate of authority to provide local exchange telecommunications services in the State of Nebraska, previously approved in Docket No. C-3942. Notice of the application was published in <a href="The Daily Record">The Daily Record</a>, Omaha, Nebraska, on May 13, 2009. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

## OPINION AND FINDINGS

On September 16, 2008, Protocall was granted authority to operate as a local exchange and interexchange telecommunications carrier within the state of Nebraska pursuant to Application No. C-3942.

By application received on March 12, 2009, Protocall requested the withdrawal of its authority to operate as a local exchange carrier of telecommunications services in the State of Nebraska. Protocall does not currently provide and does not plan to provide local exchange service in the foreseeable future. Protocall does intend to continue providing interexchange telecommunications services in Nebraska.

Upon consideration of the request and being fully advised, the Commission finds the request to be reasonable and finds that Protocall's authority to operate as a local exchange carrier of telecommunications services in the state of Nebraska should be cancelled and its local exchange tariff withdrawn.

## ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-4170 be, and it is hereby, granted and the Certificate of Public Convenience and Necessity to provide local exchange telecommunications services previously granted to Protocall LLC, is cancelled.

IT IS FURTHER ORDERED that any Protocall LLC local exchange tariffs be, and are hereby, withdrawn.
