## OPINION AND FINDINGS

On July 6, 2009, Qwest Corporation ("Qwest") of Denver, Colorado, filed an application seeking approval of a Transit Records and Jointly Provided Switched Access Services Amendment to its Interconnection Agreement with CableVision, Inc. d/b/a HunTel Communications HunTel ("HunTel"), of Blair, Nebraska. This agreement amends the Interconnection Agreement previously approved in Docket C-2921. Notice of the application was published in The Daily Record, Omaha, Nebraska, on July 8, 2009. were filed; therefore, this application protests is processed pursuant to the Commission's Rule of Modified Procedure.

On May 20, 2003, in Docket C-2921, the original interconnection agreement between Qwest and HunTel was approved by the Commission. In the current application, Qwest seeks to amend the agreement by adding a Transit Records and Jointly Provided Switched Access Services Amendment to the Interconnection Agreement. An executed copy of the amendment is contained within the application.

The amendment does not discriminate against any telecommunications carrier. Furthermore, the implementation of the amendment is consistent with the public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review negotiated interconnection agreements to ensure they comply with Sections 251 and 252(d) of the Act, as well as

all applicable state laws. Using those standards, the Amendment should be approved.
