## BY THE COMMISSION:

By application filed July 29, 2009, United Telephone of the West d/b/a Embarq, (Embarq) Overland Park, Kansas, seeks approval of an Interconnection, Collocation and Resale Agreement with TGC Omaha, (TGC) Olathe, Kansas. Notice of the application was published in <a href="The Daily Record">The Daily Record</a>, Omaha, Nebraska, on July 31, 2009. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Pursuant to Section 252(a) of the Telecommunications Act of 1996 (the Act), Embarq and TGC (parties) entered into an interconnection, collocation and resale agreement arrived at through voluntary negotiations. An executed copy of this agreement is contained within the application.

No portion of the agreement discriminates against any telecommunications carrier. Furthermore, the implementation of the agreement is consistent with the public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review extended area service agreements adopted by negotiation or arbitration to ensure they comply with Sections 251 and 252(d) of the Act, as well as all applicable state laws. Using those standards, the interconnection agreement should be approved.

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the Interconnection, Collocation and Resale Agreement between United Telephone of the West d/b/a Embarq, Overland Park, Kansas, and TGC Omaha, Olathe, Kansas, be, and it is hereby, approved.
