BY THE COMMISSION:

By application filed August 20, 2009, United Telephone Company of the West d/b/a Embarq (Embarq), Overland Park, Kansas, seeks approval of an Interconnection Agreement with NE Colorado Cellular Inc. d/b/a Viaero (Viaero), Fort Morgan, Colorado. Notice of the application was published in The Daily Record, Omaha, Nebraska, on August 22, 2009. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Pursuant to Section 252(a) of the Telecommunications Act of 1996 (the Act), Embarq and Viaero entered into an Interconnection Agreement arrived at through voluntary negotiations. An executed copy of this agreement is contained within the application.

Neither the agreement nor any portion thereof discriminates against any telecommunications carrier. Furthermore, the implementation of the agreement is consistent with the public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review interconnection agreements adopted by negotiation or arbitration to ensure they comply with Sections 251 and 252(d) of the Act, as well as all applicable state laws. Using those standards, the interconnection agreement should be approved.

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the Interconnection Agreement between United Telephone Company of the West d/b/a Embarq and NE

Colorado Cellular Inc. d/b/a Viaero, be, and it is hereby, approved.
