## BY THE COMMISSION:

By application filed August 24, 2009, Qwest Corporation (Qwest) of Denver, Colorado, seeks approval of an Amendment to the Interconnection Agreement with LH Telecom, Inc. (LH) of Des Moines, Iowa, previously granted in Docket C-3220. Notice of the application was published in <a href="The Daily Record">The Daily Record</a>, Omaha, Nebraska, on August 27, 2009. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Pursuant to Section 252(a) of the Telecommunications Act of 1996 (the Act), Qwest and LH (parties) entered into an Interconnection Agreement arrived at through voluntary negotiations and previously granted in Docket C-3220.
