BY THE COMMISSION:

On August 27, 2009, an application was filed by Alliance Global Networks, LLC (Applicant), Westport, Connecticut, seeking authority to operate as an interexchange carrier of telecommunications services within the State of Nebraska. Notice of the application was published in The Daily Record, Omaha, Nebraska, on August 31, 2009. No protests were filed; therefore, this application is processed pursuant to the Commission's rule of modified procedure.

O P I N I O N    A N D    F I N D I N G S

Applicant is a limited liability company, organized under the laws of the State of Delaware since May 1, 2008. Applicant has been authorized by the Secretary of State to operate in Nebraska as a foreign limited liability company. In addition, no officer, director or shareholder having five percent or more of the applicant's voting securities has been involved in a formal complaint or other investigatory or enforcement proceeding.

Applicant is a switchless, non-facilities based reseller of telecommunications services over the networks of its underlying carrier, AT&T. All network services will be supplied by AT&T. Applicant proposes to offer wholesale interexchange services to resellers in addition to switched and dedicated access 1+ long distance services suitable for voice and limited data applications in the State of Nebraska. Applicant does not propose to provide alternative operator services nor require advanced payments or deposits.

Interexchange applications are subject to Commission jurisdiction under Neb. Rev. Stat. § 86-129 and Title 291 of the Commission's Rules and Regulations, Chapter 5, Rule 003.12. From examination of the application filed herein, the Commission finds that Applicant has provided all the information required by the Commission, possesses adequate financial resources to provide the proposed service, and possesses adequate technical

competency to provide the proposed service. The application should be granted.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-4203 be, and it is hereby, granted and Alliance Global Networks, LLC, is authorized to operate as an interexchange carrier of telecommunications services within the State of Nebraska.

IT IS FURTHER ORDERED that, to the extent applicable, the applicant shall comply with all laws pertaining to, and all rules and regulations promulgated under, the Telecommunications Relay System Act (Neb. Rev. Stat. §§ 86-301 to 86-315) and the Nebraska Telecommunications Universal Service Fund Act (Neb. Rev. Stat. §§ 86-316 to 86-329).

IT IS FURTHER ORDERED that within **30 days** from the entry date of this order that the Applicant file a tariff and pay appropriate filing fees with the Commission as required by state statutes and the Commission's regulations.

IT IS FINALLY ORDERED that this order be, and it is hereby made, the Commission's official certificate of authority to furnish the service authorized herein as a common carrier.
