On September 1, 2009, a joint application was filed by Qwest Corporation (Qwest), Denver, Colorado, and IT Communications, LLC (IT Communications), Newton, Iowa, seeking approval of the adoption of an Interconnection Agreement previously approved in Docket C-4139 pursuant to 47 U.S.C. §252(i). Notice of the application was published in The Daily Record, Omaha, Nebraska, on September 10, 2009. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Section 252(i) of the Telecommunications Act of 1996 allows any telecommunications carrier to adopt a Commission-approved interconnection agreement. Qwest wishes to establish an Interconnection Agreement with IT Communications and accordingly seeks to adopt the BLC Management, LLC d/b/a Angles Communications Solutions interconnection agreement. The agreement was approved by the Commission pursuant to Docket C-4139 on March 10, 2009.

On May 28, 1997, the Commission added language to its mediation/arbitration policy (see Docket C-1128, Progression Order No. 3) which sets forth the procedures to be followed for a Section 252(i) request. Qwest and IT Communications have sufficiently complied with the procedures required by the Commission's policy.

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-4206 be, and it is hereby, approved and Qwest Corporation and IT Communications, LLC are hereby authorized to adopt the
