## BY THE COMMISSION:

On October 1, 2009, an application was filed by iBasis Retail, Inc. (Applicant), Burlington, Massachusetts, seeking authority to operate as an interexchange carrier of telecommunications services within the state of Nebraska. Notice of the application was published in <a href="The Daily Record">The Daily Record</a>, Omaha, Nebraska, on October 5, 2009. No protests were filed; therefore, this application is processed pursuant to the Commission's rule of modified procedure.

## OPINION AND FINDINGS

Applicant is a privately held corporation, organized under the laws of the State of Delaware since June 29, 2007. Applicant has been authorized by the Secretary of State to operate in Nebraska as a foreign corporation. In addition, no officer, director or shareholder having five percent or more of the applicant's voting securities has been involved in a formal complaint or other investigatory or enforcement proceeding.

Applicant is a switchless, non-facilities based interexchange carrier providing pre-paid calling card services. All network services will be supplied by certificated underlying carriers. Applicant proposes to offer long distance pre-paid calling card services across the State of Nebraska. Applicant will provide 24-hour customer service through a toll free 800 number. Applicant does not propose to provide alternative operator services nor require advanced payments or deposits.

Interexchange applications are subject to Commission jurisdiction under Neb. Rev. Stat. § 86-129 and Title 291 of the Commission's Rules and Regulations, Chapter 5, Rule 003.12. From examination of the application filed herein, the Commission finds that Applicant has provided all the information required by the Commission, possesses adequate financial resources to provide the proposed service, and possesses adequate technical

competency to provide the proposed service. The application should be granted.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-4214 be, and it is hereby, granted and iBasis Retail, Inc., is authorized to operate as an interexchange carrier of telecommunications services within the State of Nebraska.

IT IS FURTHER ORDERED that, to the extent applicable, the applicant shall comply with all laws pertaining to, and all rules and regulations promulgated under, the Telecommunications Relay System Act (Neb. Rev. Stat. §§ 86-301 to 86-315) and the Nebraska Telecommunications Universal Service Fund Act (Neb. Rev. Stat. §§ 86-316 to 86-329).
