By application filed November 12, 2009, United Telephone of the West d/b/a Embarq, (Embarq) Overland Park, Kansas, seeks approval of an Interconnection, Collocation and Resale Agreement with Kentucky Data Link, Inc., (Kentucky Data Link) Evansville, Indiana. Notice of the application was published in The Daily Record, Omaha, Nebraska, on November 17, 2009. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.
