BY THE COMMISSION:

By application filed December 10, 2009, Qwest Corporation (Qwest) of Denver, Colorado, seeks approval of a Type 2 Wireless Collocation and Dispute Resolution Amendment to the interconnection agreement with Verizon Wireless, (Verizon) Walnut Creek, California, previously granted in Docket C-1608. Notice of the application was published in The Daily Record, Omaha, Nebraska, on December 14, 2009. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Pursuant to Section 252(a) of the Telecommunications Act of 1996 (the Act), Qwest and Verizon (parties) entered into an interconnection agreement arrived at through voluntary negotiations and previously granted in Docket C-1608.
